Dasho,

The Secretariat would like to inform that the following decisions have been taken considering the surge of COVID19 cases in the region.

- a. The NC19TF directed to request all COVID19 Task Force members and frontline workers to stay alert and inform all colleagues, friends and family members to be cautious and follow the COVID19 norms.
- b. Irrespective of vaccination status, all incoming travellers from outside the country shall undergo 21 days mandatory facility quarantine.
- c. Travelers from high risk to low risk, will follow the 7-day quarantine strictly as follows:
 - i. The day of entry into quarantine facility will be counted as day Zero Day,
 - ii. Test on day 7 and release only after COVID19 negative result is declared.
- d. Additional measures approved by the NC19TF (conveyed vide letter No. NC19TF/01/289 dated 30 April 2021) on quarantine facility and Quarantine Individual Management to be implemented strictly by Quarantine Managers and Royal Bhutan Police.
- e. All RC19TF and DC19TF should meet to review their local SOPs and brief their respective frontline workers and communities. They are also requested to sensitize and the communities to stay vigilant and follow COVID19 norms strictly (use of face masks, Druk Trace App, wash hands and use sanitizers).

- f. All government and private agencies not to organize any meetings/ conferences / workshops unless approved by the Head of the Agency, he/ she will be held accountable in the event of COVID19 transmission from the event.
- g. Similarly any individuals found violating COVID19 norms shall be prosecuted in the Court of Law, irrespective of the persons professional background.
